All merchandise will be handled and displayed at the vendor's risk and BFM assumes no responsibility for theft, accident or natural disaster.

The undersigned agrees to indemnify and hold any sponsors of the Beavertdale Farmers Market harmless in regard to all liability for any damages to personal property, for any loss of life or personal injury or theft of property that may be sustained in connection with this event.
